### ASHRAE Baltimore High School Student Scholarship

The Baltimore Chapter of the American Society of Heating, Refrigeration, and Air Conditioning Engineers (ASHRAE Region III, Chapter 025) is pleased to offer scholarships to select graduating high school students pursuing their bachelor's degree in an ASHRAE-related or engineering field. Among other specific criteria, scholarship eligibility is open to students who have participated in the **ASHRAE Baltimore High School Student Challenge**, an annual chapter event.

Applications will be reviewed anonymously by the *ASHRAE Baltimore Student Activities Committee*, and scholarships awarded to students, following our annual ASHRAE Baltimore Chapter meeting in May, themed **"Student Night"**. Please note that the application deadline indicated below will not be extended.

### Applicant Eligibility Requirements

1. Applicant is pursuing undergraduate studies in the field of engineering. Additional preference will be given to applicants who intend to pursue an ASHRAE-related field.
2. Applicant has been accepted/admitted to a university or junior college that has been accredited by one of the following two organizations\*\*:
  - a. The [Accreditation Board for Engineering and Technology](#) (ABET).
  - b. The [Partnership for Air Conditioning, Heating, Refrigeration Accreditation](#) (PAHRA).
3. Applicant has submitted a copy of their high school transcript.
4. Applicant has submitted a letter of recommendation from a teacher or community leader.
5. It is preferred, but not required, for applicants to have previously registered for, and participated in, the annual *ASHRAE Baltimore High School Student Challenge*. Applicants who did participate will receive favorability; however, you should not be discouraged to apply if you did not.
6. Applicant is a member of the Black, Indigenous, and People of Color (BIPOC) community.

*Points are awarded based on each applicant's demonstration of the above criteria. Items 1 through 3 are required; Items 4 through 6 provide additional weight to the final consideration for awards.*

*\*\* The purpose is to establish the applicant's intent to attend a school with a qualified engineering program. If acceptance has not yet been established (usually with a formal acceptance letter), the applicant will not be disqualified if a college application has been submitted to the intended university or junior college, and this is indicated within the application.*

### Submission of Scholarship Application

Once you have determined that you meet the eligibility criteria, complete the application form and e-mail it as a PDF attachment to the current Baltimore ASHRAE Student Activities Chairperson. Please use the contact information provided on the following page (attach additional pages if needed). You may choose to print the application instead and mail it in a sealed envelope. Note that the envelope must be postmarked before the deadline listed on the following page.

Application materials provided by others must be directly forwarded, either by mail or e-mail (PDF), to the Student Activities Chairperson. This may include official high school transcripts, recommendation letters, etc. If materials are given (sealed) directly to you, they must also be postmarked no later than the deadline stated on the following page. Incomplete applications will be disqualified for review by the Student Activities Committee. The Chairperson will confirm receipt and successful submission of application forms using the e-mail address provided to us.
